### Price Monitoring & Resource Unit (PMRU)

#### Context:

J&K sets up PMRU of NPPA.

#### Details:

- Jammu & Kashmir Union Territory has become 12<sup>th</sup> State/UT where the Price Monitoring & Resource Unit (PMRU) has been set up by the National Pharmaceutical Pricing Authority (NPPA).
- PMRUs have already been set up by the NPPA in 11 States, including Kerala, Odisha, Gujarat, Rajasthan, Punjab, Haryana, Nagaland, Tripura, Uttar Pradesh, Andhra Pradesh and Mizoram.

#### About PMRU:

- The PMRU, a registered society, shall function under the direct control and supervision of the State Drug Controller of Jammu & Kashmir.
- The unit shall be funded by the NPPA for its recurring and non-recurring expenses.
- The PMRU shall help the NPPA and the State Drug Controller in ensuring the availability and accessibility of medicines at affordable prices.
- It is also expected to organise seminars, training programs and other information, education and communication (IEC) activities in the areas of availability and affordability of medicines for all.
- The PMRU will also collect samples of medicines, collect and analyse data and make reports with respect to availability and overpricing of medicines for taking action under the provisions of the Drug Price Control Order (DPCO).
- **PMRU Mandate:** To track violation of prices of essential drugs and medical devices under the Drugs Price Control Order (DPCO).

- **PMRU Functions:** Offering technical help to the State Drug Controllers and the NPPA to –
- Monitor notified prices of medicines,
- Detect violation of the provisions of the DPCO,
- Look at price compliance, collect test samples of medicines, and
- Collect and compile market-based data of scheduled as well as non-scheduled formulations.

The PMRU is chaired by the State Health Secretary. The Member-Secretary would be Drugs Controller.

### India Post Payments Bank

#### Context:

During the lockdown period till March end, 6.5 lakh transactions were effected through the IPPB (India Post Payments Bank).

### Food Corporation of India (FCI)

#### Context:

FCI ramps up food grain supplies across the country during the lockdown due to COVID-19 outbreak.

#### About the FCI:

- Food Corporation of India (FCI) is a Public Sector Undertaking, under the Department of Food & Public Distribution, Ministry of Consumer Affairs, Food and Public Distribution, GOI.
- It is a statutory body set up in 1965 under the Food Corporations Act, 1964. It was established against the backdrop of major grains shortage, especially of wheat.
- **FCI Objectives:**
- To provide farmers remunerative prices
- To make food grains available at reasonable prices, particularly to vulnerable sections of society
- To maintain buffer stocks for food security

- To intervene in market for price stabilization

### About COVID-19

#### Context:

What do we know and what do we need to know about Novel Coronavirus.

#### Details:

##### Infection

- The virus infects the epithelial cells in the throat and lungs.
- SARS-CoV-2 binds to the ACE2 receptors on human cells, which are often found mostly in throats and lungs.
- Virus on the skin, lacking ACE2 expression, will be harmless.
- The virus enters through the body through the nasal passage, eyes and mouth.
- Our hands are the main instruments that take the virus to reach our mouth, nose and eyes.
- Washing hands with soap water for 20 seconds as often as possible helps prevent the infection.

##### Infectious dosage

- A dose of 700000 PFU was needed to infect a Macaque.
- PFU (Plaque forming unit) is a unit of measurement of sample infectivity.

Although the animal did not show any clinical symptoms, the droplets from the nose and the saliva had a viral load.

Humans will need a higher dosage than 700000 PFU to get infected.

An animal study on genetically modified mice with ACE2 receptors showed that it could be infected with SARS with just 240 PFU. In comparison, it required 70,000 PFU of novel coronavirus to get infected.

##### Infectious period

- Length of time an individual can transmit the infection to others is not known precisely, but possibly up to 10-14 days.
- Artificially reducing the contagious period is a crucial method of reducing overall transmission.
- Hospitalisation, isolation, lockdown and quarantine are all effective methods.

##### Who can infect?

- Anyone infected with the virus can infect others even before the symptoms appear.
- Most carriers do not even show signs.
- Covering our mouth and nose when we cough or sneeze will help reduce the infection.
- The virus is present in the saliva, sputum and faeces of the infected person for the whole infectious period.

##### How we infect?

- Transmission is mostly via droplets.
- This requires relatively close contact, less than 6 feet.
- This is why it is recommended that we stay 1.5 metres away from each other in public places.

Inanimate vector of disease, in particular phones, doorknobs, surfaces are a potential source for transmission, but not much is known about it.

It is prudent to sanitise our hands after touching doorknobs, lift call buttons and counters in public places.

##### How many we infect?

- The average number of new infections caused by a typical infectious person, that is human transmissibility range ( $R_0$ ) is between 2.2 to 3.1.
- In simple words, one infected individual on the average infects about 2.2 to 3.1 persons.

By physical distancing, we can artificially reduce the actual transmissibility, thus slowing the rate of infection.

### Where did the virus come from?

- It is not from eating bat soup. Once you boil, the virus is decimated.
- Initially, it was speculated that the SARS-CoV-2 virus jumped from bat to humans. But recent genomes study show first it must have leapt from bat to an intermediary species before it latched on to humans.
- Another study indicates that a lineage of SARS-CoV-2 virus was circulating in humans before the disease outbreak.

### How it evolved?

- SARS-CoV-2 has emerged either by:
- Natural selection of virulent strain in a non-human animal host before zoonotic transfer to humans, or
- Natural selection of virulent strain in humans following a zoonotic transmission.

Only more studies will show which of the two is right.

Scientists are still not clear what are the mutations in SARS-CoV-2 that allowed human infection and transmission.

### When did SARS-CoV2 emerge?

- While there have been no documented cases of SARS-CoV2 before December 2019, preliminary genomic analyses suggest that the first human cases of SARS-CoV-2 appeared between mid-October and mid-December 2019.
- This means there was a period of unrecognised transmission in humans between the primary zoonotic event and the outbreak.

### Can it infect animals?

- The molecular modelling suggests that SARS-CoV-2 can affect besides human, bat, civet, monkey and swine cells.

- It does not infect domestic animals or livestock. Consuming eggs or poultry will not result in SARS-CoV-2 infection.

### Can one be infected twice?

- Experimentally infected macaques were not capable of being re-infected.
- Likewise, there is no evidence of reinfection with SARS-CoV-2 after recovery in humans.
- However, how long the immunity will last is unknown.

### How severe is the illness?

- The majority of COVID-19 cases are mild (81%), about 15% need hospitalisation and 5% require critical care.
- That is, the vast majority of the infected will not even need hospitalisation.

### Who are the most vulnerable?

- Healthcare workers
- People above 60 years of age
- People with prior cardiovascular disease, hypertension, diabetes, and respiratory conditions

### What is the cause of death?

- Most of the deaths are caused by respiratory failure or respiratory failure combined with heart damage.
- Leakage of fluid into the lungs, which inhibits respiration and leads to morbidity, is the primary clinical condition.
- At present, the treatment for COVID-19 is primarily supportive care, including ventilation if necessary. Several therapeutic trials are ongoing, and the results are awaited.

### Will the virus spread through air?

- In the air, the virus can survive only up to 2.7 hours. Therefore being in open spaces such as a balcony or the terrace is no harm.

### Is there a less virulent strain?

- While many strains are being identified, studies so far have not indicated any mutations that are linked to any changes in transmission or disease severity.

### Will the onset of summer bring any respite?

- No strong evidence exists showing a reduction in transmission with the seasonal increase in temperature and humidity.

### e-NAM

#### Context:

Union Agriculture Minister launches new features of e-NAM platform.

#### Details:

- The new features aim to strengthen agriculture marketing by farmers which will reduce their need to physically come to wholesale mandis for selling their harvested produce, at a time when there is critical need to decongest mandis to effectively fight against COVID-19.
- These software modules are:
- Warehouse based trading module in e-NAM software to facilitate trade from warehouses based on e-NWR (Electronic Negotiable Warehouse Receipts).
- FPO trading module in e-NAM whereby FPOs can trade their produce from their collection centre without bringing the produce to APMC.

In addition to facilitate inter-mandi and inter-state trade at this juncture, enhanced version of logistic module has been released whereby aggregators of transport logistic platform have on-boarded which helps users to avail trackable transport facilities for transporting their produce.

### Three modules have been launched for enhancing the effectiveness of e-NAM:

I) Launch of Negotiable Warehouse Receipt (e-NWRs) module in National Agriculture Market (e-NAM) software.

- Warehouse (Registered with WDRA – Warehousing Development and Regulatory Authority) trading module with payment feature is launched to enable small & marginal farmers to directly trade their stored produce from selected WDRA registered warehouses which are declared deemed market by the State.
- Farmers will be able to place their produce in WDRA accredited warehouses.
- Already States of Telangana (14 warehouses) & Andhra Pradesh (23 warehouses) declared designated warehouses in the State as deemed market.

#### • Benefits of e-NWRs integration with e-NAM:

- Depositor can save the logistics expenses and will have better income.
- Farmers can sell the produce across the nation to get better price and at the same time avoid the hassle of mandis.
- Farmers will be able to place their produce in WDRA accredited warehouses and avail the benefit of pledge loan if required.
- Price stabilization by matching supply and demand through time and place utility.

#### II) FPO trading module

- FPO trading module is launched to enable FPOs to upload their produce from their premise/collection centres for bidding. They can upload the picture of the produce and quality parameters from their premises to help distant bidders to visualise the produce before bidding.
- FPOs have the option for delivery of produce either from their premises or by bringing to mandi premise after successful bidding. This will not only decongest the mandis but also reduce the logistics cost for the FPOs.
- Facility provided to FPO to upload assaying report/photo of their produce from their premise

to enable traders to visualise the produce before bidding.

### Benefits:

- This will not only decongest the mandis but also reduce the hassle of FPOs in dealing with mandis.
- This will help FPOs by reducing transaction costs (Transportation) and enhancing their bargaining power.
- Facilitates FPOs to avail online payment facility with ease of doing business.

### III) Launch of Logistic Module

- Presently, e-NAM provides a database of individual transporters to the traders.
- However, as a quantum response to logistic need by traders, provision has been made for linking large logistic aggregator platforms, which will provide choices to users.
- Traders would be able to use the link to navigate to the logistics provider's website and select appropriate services.
- With these additions, more than 3,75,000 number of trucks from large logistic providers would be added for logistic purpose.

### • Benefits:

- This will help in seamless transportation of agricultural produce.
- This will promote inter-State trade under e-NAM by providing online transport facilities for distant buyers.

## Low Cost Temperature Gun

### Context:

Naval Dockyard Mumbai designs low cost Temperature Gun.

### Details:

- Naval Dockyard, Mumbai has designed and developed its own handheld IR based

temperature sensor for undertaking screening of large number of personnel at the entry gates of the yard reducing the load on the security sentries at the gate.

- The instrument has been manufactured under Rs. 1000/- through in-house resources (which is a fraction of the cost of the Temperature Guns in the market).
- The non-contact thermometer has an Infrared sensor and an LED display integrated with a microcontroller which runs on a 9V battery.
- Since the COVID-19 outbreak, the non-contact thermometers or temperature guns have become scarce in the market and are being sold at a very high cost.
- The most preliminary method to screen a probable patient is to check for body temperature by non-contact means.

## AarogyaSetu App

### Context:

The Government of India launched a mobile app 'AarogyaSetu' developed in public-private partnership to bring the people of India together in a resolute fight against COVID-19.

### About AarogyaSetu:

- The App joins Digital India for the health and well-being of every Indian.
- It will enable people to assess themselves the risk for their catching the Corona Virus infection.
- It will calculate this based on their interaction with others, using cutting edge Bluetooth technology, algorithms and artificial intelligence.
- Once installed in a smart phone through an easy and user-friendly process, the app detects other devices with AarogyaSetu installed that come in the proximity of that phone.
- The app can then calculate the risk of infection based on sophisticated parameters if any of these contacts is tested positive.

### National Corona Survey

#### Context:

Union Minister released the COVID 19 National Preparedness Survey 2020.

#### About the National Preparedness Survey on COVID-19 (National Corona Survey):

- The survey was conducted in 410 districts within 3 working days to attain a bird's eye view of the governance challenges of the nation while coping with the COVID-19 pandemic.
- **Objectives of the Survey:**
- To develop a comparative analysis of COVID 19 preparedness across States.
- To highlight the main priorities and constraints of COVID 19 preparedness, as they are perceived by the civil servants working in the field.

- To access enabling factors in making institutional/logistics/hospital preparedness, etc.
- To capture trends to identify systemic and process related deficiencies, in combating COVID 19 in the districts of India.
- The survey was conducted across all districts of India, with responses from 410 civil servants who are providing field level leadership. District Collectors and IAS officers of (2014-2018) batches who have served as Assistant Secretaries in Government of India participated in the survey.

### ECI further defers Rajya Sabha poll in view of COVID-19

#### What's in News?

Election Commission of India (ECI) has deferred the Rajya Sabha Polls in view of the current unforeseen situation of a public health emergency,.

- ECI, invoking its powers under Article 324 of the Constitution of India read with section 153 of the Representation of the People Act, 1951 has further extended the period of Rajya Sabha election beyond the prescribed term(s) of 18 seats across seven States.

#### Article 324:

Article 324 of the Constitution provides that the power of superintendence, direction and control of elections to parliament, state legislatures, the office of president of India and the office of vice-president of India shall be vested in the election commission.

- Video conference has been conducted with all States and Insurance companies to review the payment of claims, crop loss survey and implementation of Smart Sampling Technique.
- For facilitating farm insurance, letters have been issued to all States to issue passes to representatives of concerned Insurance companies for co-witnessing Crop Cutting Experiments and to relax the norms for conducting field level survey for intimation received for Post-Harvest crop losses due to unseasonal rainfall and hailstorm.
- Phytosanitary certification for export consignments and Import releases of plant and plant products are continuing.
- For providing support to horticulture crops necessary coordination is being done with growers, aggregators, wholesalers, mandi associations, State Horticulture Missions, for smooth transport of the commodities and to sort out all difficulties.
- Kisan Call Centres are being operated by diverting calls to individual mobile numbers of Farm Tele Advisors, who are now operating from homes.

### Lifeline UDAN Flights

#### What's in News?

Over 1 lakh km of aerial distance covered by Lifeline UDAN flights.

- As part of India's war against the novel Coronavirus pandemic, the Ministry of Civil Aviation has launched "Lifeline Udan".
- Under this initiative, flights are being operated for the movement of essential and medical supplies across the nation.
- The flights under Lifeline Udan are planned using a hub and spoke model.

- Cargo hubs have been set up at Mumbai, Delhi, Kolkata, Hyderabad and Bangalore.
- The flights connect these hubs and therefrom to different parts of India.
- The North East Region, island territories and the hill states are being given special focus.
- On the international front of this initiative, Air India has established a cargo air-bridge between China and India.
- Regular cargo flights are likely to be operated by Air India for transporting critical medical equipment and supplies between the two countries.

alcoholic aqueous-based Colloidal Silver solution for disinfecting hands and environmental surfaces.

- This liquid is noninflammable and free of hazardous chemicals and can be an effective sanitizer to prevent the spread of the COVID-19 infection.
- It has been developed through the NanoAgCide technology
- This sanitizer is based on the ability of the silver nanoparticles to prevent the synthesis of viral negative-strand RNA and viral budding.
- An Indian patent has been filed for the process of making colloidal silver, and a test license for making hand sanitizers and disinfectants has been granted.

### Nanoparticles:

- Nanoparticles are rapidly emerging as effective solutions to a variety of issues related to COVID-19, from theranostics (therapy plus diagnostics) to disinfection and imaging.

### Updates on COVID-19

#### Context:

The government has released a few figures on the COVID-19 situation in the country.

#### Details:

- As of now, **4067 confirmed cases** and **109 deaths** have been reported. 291 persons have been cured/discharged after recovery.
- As per the currently available data, an analysis of the total confirmed cases has presented the following distribution:
- Gender distribution:
  - 76% are male
  - 24% are female
- Age distribution:
  - 47% people – below 40 years age group

- 34% people – between 40 to 60 years age group
- 19% people – 60 and above age group
- Following observations are made while analysing the reported 109 deaths due to COVID-19:
  - Gender distribution:
    - 73% are male
    - 27% are female
  - Age distribution:
    - 63% deaths reported for elderly people (60 and above)
    - 30% deaths reported for people between 40 to 60 years
    - 7% deaths reported for people below 40 years
- As of now, 86% death cases have exhibited comorbidity related to diabetes, chronic kidney issues, hypertension and heart related problems.
- Although 19% confirmed cases have been reported among the elderly, since 63% deaths have been observed among them, **elderly people form a high risk population.**
- Further, though 37% deaths are reported from people below 60 years, approximately, 86% of deaths amongst people with co-morbidities indicate that **young people with co-morbidities are also at high risk of COVID-19.**

- Under the "Samadhan" challenge, students and faculty will be motivated for conducting new experiments and new discoveries and providing them with a strong base leading to a spirit of experimentation and discovery.

### Ministry of Corporate Affairs (MCA)

#### Context:

MCA allows companies to hold Extraordinary General Meetings (EGMs) through VC or OAVM complemented with e-Voting facility/simplified voting through registered emails.

#### Details:

- Taking stock of the coronavirus situation, the MCA had earlier allowed all meetings of the Board of Directors up to 30<sup>th</sup> June 2020, to be conducted through Video Conferencing (VC) or other audio visual means (OAVM) vide its notification date 19.03.2020, including meetings on items where the physical presence of directors is otherwise required.
- In furtherance of the Government's objective of facilitating corporate compliances during the current lockdown period and other restrictions on account of COVID-19, the Ministry has issued a circular allowing companies to hold Extraordinary General Meetings (EGMs) through VC or OAVM complemented with e-Voting facility/simplified voting through registered emails, without requiring the shareholders to physically assemble at a common venue.
- The Companies Act, 2013 allows ordinary and special resolutions to be passed through postal ballot/e-voting route without holding a physical general meeting. However, in the present lockdown/social distancing conditions due to COVID-19, postal ballot facility cannot be utilized by the companies.

- The framework leverages the strengths of Digital India by using a combination of VC and e-Voting/simplified voting through registered emails to enable companies conduct their EGMs.
- As the meetings will be conducted over VC/OAVM, the facility for appointment of proxies has been dispensed with, while representatives of bodies corporate will continue to get appointed for participation in such meetings.
- This framework allows the companies to hold shareholders' EGMs through VC/ OAVM without compromising on the other requirements of law.
- As an additional check, all companies using this option are required to maintain a recorded transcript of the entire proceedings in safe custody, and public companies are also required to host this transcript on their website for greater transparency.
- Further, all resolutions passed through this framework will be required to be filed with the RoC within 60 days, so that such resolutions may be viewed publicly.

### Madhuvan Gajar

#### Context:

Biofortified carrot variety developed by farmer scientist benefits local farmers.

#### Details:

- Madhuban Gajar, a biofortified carrot variety with high  $\beta$ -carotene and iron content developed by a farmer scientist from Junagadh

district, Gujarat is benefitting more than 150 local farmers in the area.

- It is being planted in an area of over 200 hectares in Junagadh, and the average yield, which is 40-50 t/ha, has become the main source of income to the local farmers.
- The variety is being cultivated in more than 1000 hectares of land in Gujarat, Maharashtra, Rajasthan, West Bengal, Uttar Pradesh during the last three years.
- The Madhuban Gajar is a highly nutritious carrot variety developed through the selection method with higher  $\beta$ -carotene content (277.75 mg/kg) and iron content (276.7 mg/kg) dry basis and is used for various value-added products like carrot chips, juices, and pickles.
- Among all the varieties tested, beta-carotene and iron content were found to be superior.
- In trials conducted by the National Innovation Foundation, it was found that the Madhuban Gajar carrot variety possesses a significantly higher root yield (74.2 t/ha) and plant biomass (275 gm per plant).
- This variety was developed by farmer-scientist Shri Vallabhhai Vasrambhai Marvaniya.
- During 1943, he found that a local carrot variety was profoundly used for fodder to improve the quality of milk.
- He selectively cultivated this variety and sold this carrot in the market at a good price. Since then, he, along with family, is working for the conservation and development of this cultivar.
- In the 1950s, he started cultivating this on a large-scale.
- He also started distributing the seeds to other farmers in his village and adjoining areas in the 1970s.
- During 1985, he started selling the seeds on a large scale.
- Shri Marvaniya was conferred with a National Award by the President of India during the Festival of Innovation (FOIN) – 2017.

## Piezoelectricity

- Piezoelectricity (also called the piezoelectric effect) is the ability of certain materials to generate an electric charge in response to applied mechanical stress.
- The word Piezoelectric is derived from the Greek word Piezein, which means to squeeze or press, and piezo, which is Greek for "push".
- The piezoelectric effect is a reversible process: materials exhibiting the piezoelectric effect (the internal generation of electrical charge resulting from an applied mechanical force) also exhibit the reverse piezoelectric effect, the internal generation of a mechanical strain resulting from an applied electrical field.
- French physicists Jacques and Pierre Curie discovered piezoelectricity in 1880

### Piezoelectric Materials

There are many materials, both natural and man-made, that exhibit a range of piezoelectric effects.

- Some **naturally** piezoelectric occurring materials include Berlinite (structurally identical to quartz), cane sugar, quartz, Rochelle salt, topaz, tourmaline, and bone (dry bone exhibits some piezoelectric properties due to the apatite crystals, and the piezoelectric effect is generally thought to act as a biological force sensor).
- An example of **man-made** piezoelectric materials includes barium titanate and lead zirconate titanate.

### Applications

- Piezoelectricity is exploited in a number of useful applications, such as the production and detection of sound, piezoelectric inkjet printing, generation of high voltages, electronic frequency generation, microbalances, to drive an ultrasonic nozzle, and ultrafine focusing of optical assemblies.
- It forms the basis for a number of scientific instrumental techniques with atomic resolution,

the scanning probe microscopies, such as scanning tunneling microscope (STM), Atomic force microscopy (AFM)

- It also finds everyday uses such as acting as the ignition source for cigarette lighters, push-start propane barbecues, used as the time reference source in quartz watches

### Context

- Researchers from Institute of Nano Science and Technology (INST), Mohali an autonomous institute under the Department of Science & Technology, have made computer based designs of nano-materials with superhigh piezoelectricity which can be the building blocks of futuristic nano-electronics for applications like ultrathin, next-generation nano-transistors.
- The research demonstrated induction of superhigh out-of-plane piezoelectricity via stacking one monolayer over the other in the 2D nanostructure.

### Details

- The induction of this phenomenon is based on two-dimensional van der Waals Heterostructure (vdWH) comprising of 2D monolayers
- The vdWH is a new approach in materials design where different monolayers having complimentary properties are combined together to surmount their intrinsic limitations.
- When two monolayers are stacked over one another to constitute a vdWH, various factors affect the electronic properties.

The dipoles arising at the interface due to the large charge density difference between the two constituent monolayers extend out into the interlayer region, which result in such an ultrahigh value in out-of-plane piezoelectricity.

- Contribution made to 'PM CARES Fund' shall qualify as Corporate Social Responsibility (CSR) expenditure under Schedule VII of the Companies Act, 2013

### Note:

- Contributions made to 'Chief Minister's Relief Funds' or 'State Relief Fund for COVID-19' shall not qualify as admissible CSR expenditure.
- Contribution made to State Disaster Management Authority to combat COVID-19 shall qualify as CSR expenditure.
- Payment of salary/ wages in normal circumstances is a contractual and statutory obligation of the company. Similarly, payment of salary/ wages to employees and workers even during the lockdown period is a moral obligation of the employers, as they have no alternative source of employment or livelihood during this period. Thus, payment of salary/ wages to

employees and workers during the lockdown period (including imposition of other social distancing requirements) would not qualify as admissible CSR expenditure.

- If any ex-gratia payment is made to temporary / casual workers/ daily wage workers over and above the disbursement of wages, specifically for the purpose of fighting COVID 19, the same shall be admissible towards CSR expenditure as a onetime exception provided there is an explicit declaration to that effect by the Board of the company, which is duly certified by the statutory auditor.

### PM Gareeb Kalyan Yojna

#### What's in News?

- EPFO has put in place Online Mechanism to credit EPF and EPS Accounts of Subscribers as per PM Gareeb Kalyan Yojna.

#### Details:

- Garib Kalyan package is a range of measures that the Government of India will take to alleviate the economic, health, and food-related distress of India's poor.

### Central Administrative Tribunal

- The Central Administrative Tribunal (CAT) was established in 1985 through the Administrative Tribunals Act.
- The CAT is responsible for adjudication or trial of matters connected with recruitment and conditions of service of personnel in public service in India.
- The CAT was created by the Act in 1985 under Article 323A of the Constitution of India. The Tribunal derives its jurisdiction, powers and authority from this Section.
- It was established via the 42<sup>nd</sup> Constitutional Amendment of the Constitution.

### Convalescent-plasma therapy

#### What is convalescent-plasma therapy?

- Convalescent Plasma therapy involves transfusing certain components from the blood of people who have recovered from a virus attack into people who are very sick with the virus or people who are at high risk of getting the virus.
- When a pathogen like novel coronavirus infects, our immune systems produce antibodies.
- The antibodies span out to identify and mark the invading virus.
- White blood cells attach the identified intruders, and the body gets rid of the infection.
- The therapy, like blood transfusion, harvests the antibody from a recovered patient and ingest into a sick person.
- Helped by the antibody, the immune system mounts robust combat on the virus.

#### What are antibodies?

- Antibodies are one of the front-line immune response to an infection by a microbe.
- They are a particular type of proteins secreted by immune cells called B lymphocytes when they encounter an invader, such as a novel coronavirus.
- The immune system designs antibodies that are highly specific to each invading pathogen. A particular antibody and its partner virus are made for each other.

#### How the treatment is given?

- Blood is drawn from a person who has recovered from COVID-19 sickness.
- The serum is separated and screened for virus-neutralizing antibodies.
- Convalescent serum, that is the blood serum obtained from one who has recovered from an infectious disease and especially rich in antibodies for that pathogen, is then administered to a COVID-19 patient.
- The sick acquires passive immunisation.
- Potential donor would be examined before the blood serum is extracted and given to a sick person. First, the swab test must be negative and the potential donor has to be declared as cured. Then the recovered person has to wait for two weeks. Or else the potential donor should be asymptomatic for at least 28 days. Either of the two is mandatory.

#### How is it different from vaccination?

- This therapy is akin to passive immunization.
- When a vaccine is administered, the immune system produces the antibodies. Thus, in a later date, when the vaccinated person is infected by that pathogen, the immune system releases the antibodies and neutralises the infection.
- Vaccination provides lifelong immunity.
- In the case of passive antibody therapy, the effect lasts only up to the time the antibodies injected remain the bloodstream. The protection given is temporary.

- Three ICAR institutes are engaged in COVID-19 testing on humans.

## Defense Research and Development Organisation (DRDO)

### Context:

Defence Research & Development Laboratory (DRDL), Hyderabad has added another product to the portfolio of the Defence Research and Development Organisation (DRDO) to combat COVID-19 by developing **COVID Sample Collection Kiosk (COVSACK)**.

### About COVSACK:

- The COVSACK is a kiosk for use by healthcare workers for taking COVID-19 samples from suspected infected patients.
- Patient under test walks into the kiosk and a nasal or oral swab is taken by a health care professional from outside through the built-in gloves.
- The kiosk is automatically disinfected without the need for human involvement, making the process free of infection spread.
- The shielding screen of the kiosk cabin protects the health care worker from aerosols/droplet transmission while taking the sample. This reduces the requirements of PPE change by health care workers.
- After the patient leaves the kiosk, four nozzle sprayers mounted in the kiosk cabin disinfect the empty chamber by spraying disinfectant mist for a period of 70 seconds.
- It is further flushed with water & UV light disinfection.
- The system is ready for next use in less than two minutes.

- Voice command can be given through two-way communication system integrated with the COVSACK.

- It is possible to configure COVSACK to be used either from inside or outside as required by the medical professionals.

- The COVSACK costs nearly Rs One Lakh and the identified industry based at Belgaum, Karnataka can support 10 units per day. The DRDO has designed and developed two units and handed over these to ESIC Hospital, Hyderabad after successful testing.

## SWAYAMPRAKHA

### Context:

The NIOS (National Institute of Open Schooling) of HRD Ministry initiates a unique method to ensure effective schooling to reach the unreached directly at door step.

### Details:

- Content is being made available online through 'SWAYAM' MOOC platform of the MHRD for various subjects from class 9<sup>th</sup> to 12<sup>th</sup>.
- Along with Self Learning Material, 'SWAYAM' portal provides video lectures and facility for self-assessment.
- The questions and queries of the learners are also being resolved through discussion forums.

For those who do not have much access to the internet, these video lectures are telecast on the MHRD SWAYAMPRAKHA TV channels with live sessions for students to interact with their teachers and subject experts.

Learners can watch the lesson-based educational programs on three DTH Channels and the NIOS YouTube channel.

Learners can ask questions directly to the subject experts from their home through phone call on the number displayed during live sessions and through 'Student Portal' of NIOS web site directly in live telecast.

- The channels are uplinked from **BISAG**, Gandhinagar.
- BISAG is a State level nodal agency to facilitate the use of spatial and geo-spatial technologies for the planning and developmental activities pertaining to Agriculture, Land and Water Resource Management, Wasteland/Watershed Development, Forestry, Disaster Management, Infrastructure and Education.
- The Institute started its operations in April 1997 and was renamed as the "Bhaskaracharya Institute for Space Applications and Geo-informatics" in December 2003.
- It was formerly known as Remote Sensing and Communication Centre (RESECO).

### Initiatives of Department of Agriculture, Cooperation & Farmers' Welfare to promote farming and allied sectors during lockdown

The Department of Agriculture, Cooperation and Farmers' Welfare, Government of India is taking several measures to facilitate farming activities at the field level during the lockdown period.

**The following are the measures taken:**

1. The following exemptions were given by the GOI for agricultural operations during the lockdown keeping in view the harvesting and sowing season:
  - a. Agencies engaged in the procurement of agriculture products, including MSP operations;
  - b. Farming operations by farmers and farm workers in the field;
  - c. 'Mandis' operated by the Agriculture Produce Market Committee (APMC) or as notified by the State Government;
  - d. 'Mandis' include direct marketing facilitated by the State Government/UT administration, directly from the farmers/groups of farmers, FPOs, cooperatives, etc.;
  - e. Shops for seeds, fertilisers and pesticides;
  - f. Manufacturing and packaging units of seeds, fertilisers and pesticides;
  - g. Custom Hiring Centres (CHC) related to farm machinery;
  - h. Intra and inter-state movement of harvesting and sowing related machines like combined harvester and other agriculture/horticulture implements;
  - i. Cold storage and warehousing services;
  - j. Manufacturing units of packaging material for food items;
  - k. Transportation for essential goods;
  - l. Shops of agriculture machinery, its spare parts (including its supply chain) and repairs;
  - m. Tea industry, including plantation with maximum of 50% workers.
2. The **All India Agri Transport Call Centre** has been launched.
  - a. This Call Centre has been set up for coordination between States for inter-state movement of perishables like vegetables & fruits, agri inputs like seeds, pesticides and fertilizers, etc.
3. **Pradhan Mantri Kisan Samman Nidhi (PM-KISAN)** Scheme
  - a. Under the PM-KISAN scheme, about 8.46 crore farmers have been benefitted and an amount of Rs. 16,927 crore has been released so far.

### India's Foreign Trade

#### Context:

India's overall exports (Merchandise and Services combined) in April-March 2019-20 are estimated to be USD 528.45 billion.

#### Details:

- This shows a negative growth of (-) 1.36 per cent over the same period last year.
- Overall imports in April-March 2019-20 are estimated to be USD 598.61 billion, exhibiting a negative growth of (-) 6.33 per cent over the same period last year.

- Rise in import in March 2020 was witnessed only in Transport equipment, which registered a growth of 11.94% over March 2019.

#### • Trade Balance:

- **MERCHANDISE:** The trade deficit for March 2020 was estimated at USD 9.76 billion as against the deficit of USD 11.00 billion in March 2019.
- **SERVICES:** As per RBI's Press Release dated 15<sup>th</sup> April 2020, the trade balance in Services (i.e. Net Services export) for February 2020 is estimated at USD 6.66 billion.
- **OVERALL TRADE BALANCE:** Taking merchandise and services together, overall trade deficit for April-March 2019-20 is estimated at USD 70.16 billion as compared to USD 103.32 billion in April-March 2018-19.

### Wholesale Price Index (WPI)

- Sree Chitra Tirunal Institute for Medical Sciences and Technology, Trivandrum, an Institute of National Importance, of the Department of Science and Technology (DST), has developed a diagnostic test kit that can confirm COVID-19 in 2 hours at a low cost.
- The confirmatory diagnostic test, which detects the N Gene of SARS- COV2 using reverse transcriptase loop-mediated amplification of viral nucleic acid (RT-LAMP), will be one of the world's first few if not the first of its kind in the world.

- The test kit, funded by the DST called Chitra GeneLAMP-N, is highly specific for SARS-CoV-2 N-gene and can detect two regions of the gene, which will ensure that the test does not fail even if one region of the viral gene undergoes mutation during its current spread.
- The tests performed at National Institute of Virology (NIV) Alappuzha (authorized by ICMR) show that Chitra GeneLAMP- N has 100% accuracy and match with test results using RT-PCR.
- This has been intimated to ICMR, the authority to approve COVID-19 testing in India, following which license needs to be obtained from the Central Drugs Standard Control Organisation (CDSCO) for manufacture.
- **Benefits of GeneLAMP-N:**
  - Current PCR kits in India enable detection of E gene for screening and RdRp gene for confirmation. Chitra GeneLAMP-N gene testing will allow **confirmation in one test without the need for a screening test and at much lower costs.**
  - The detection time is 10 minutes, and the sample to result time (from RNA extraction in swab to RT-LAMP detection time) will be less than 2 hours.
  - A total of 30 samples can be tested in a single batch in a single machine allowing a large number of samples to be tested each day.
  - The testing facility can be easily set up even in the laboratories of district hospitals with limited facilities and trained laboratory technicians.
  - The results can be read from the machine from the change in fluorescence.
  - The cost of testing with the new device for LAMP testing and the test kit for 2 regions of N gene (including RNA extraction) will be less than Rs 1000/test for the laboratory.

### Heavy Metal Detection in Water

Context:

The Centre for Nano and Soft Matter Sciences (CeNS) has developed a compact solid-state sensor to detect heavy metal ions in water.

#### Details:

- It is a portable device which can help onsite detection in remote areas.
- The CeNS's research team has developed a compact solid-state sensor to detect the heavy metal ions, e.g., lead ions (Pb<sup>2+</sup>) down to 0.4 parts per billion (ppb) for efficient onsite detection.
- The sensor film was prepared by forming a composite between manganese doped zinc sulfide quantum dots and reduced graphene oxide on a glass substrate.
- These particular quantum dots are water-soluble and have high photoluminescence (~ 30 %) quantum yield, making them suitable for luminescence-based sensing.
- These quantum dots can be excited with a handheld UV light of 254 nm, thus making it a portable device even to remote areas.
- If a drop of water containing heavy metal ions such as mercury, lead, cadmium, etc. are added to the composite film, the emission of the film quenches within seconds.

#### Heavy metal ions in water:

- Heavy metal ions such as lead, mercury and cadmium pose severe potential threats to living beings as they can easily be accumulated in the body and cannot be detoxified by any chemical or biological processes.
- The health hazards associated with heavy metal ions in water demands the development of efficient and portable sensors for rapid onsite detection of these ions.

- **Primary transportation** would include movement from Farm to Mandis, Farmer Producer Organisation (FPO) Collection Centre and Warehouses etc.
- **Secondary Transportation** would include movement from Mandis to Intra-state & Inter-state mandis, Processing units, Railway station, Warehouses and Wholesalers etc.

This mobile application is developed by the National Informatics Centre (NIC).

- It will bring together 5 lakh trucks and 20,000 tractors on the mobile platform for transporting farm produce to markets from the farm gate.

### Significance:

- The Mobile Application named "Kisan Rath" facilitates Farmers and Traders in identifying the right mode of transportation for movement of farm produce ranging from foodgrain (cereal, coarse cereal, pulses etc), Fruits & Vegetables, oil seeds, spices, fiber crops, flowers, bamboo, log & minor forest produce, coconuts etc.
- This App also facilitates traders in the transportation of perishable commodities by Reefer (Refrigerated) vehicles during the lockdown.

### Context

### Price Support Scheme (PSS):

- The Government's price policy for agricultural commodities seeks to ensure **remunerative prices to the growers for their produce** with a view to encourage higher investment and production and to safeguard the interest of consumers by making available supplies at reasonable prices with low cost of intermediation.

- Besides NAFED, the Government also organizes procurement operations of these agricultural commodities through various public and cooperative agencies such as FCI.
- The **expenditure** and **losses** due to procurement will be **borne by the Centre**.

### Lifeline Udan

#### What's in News?

'Lifeline Udan' flights are being operated by Ministry of Civil Aviation (MoCA) to transport **essential medical cargo to remote parts of the country** to support India's war against COVID-19.

### Government amends the extant FDI policy

#### What's in News?

The Government of India has **reviewed the extant Foreign Direct Investment (FDI) policy for curbing opportunistic takeovers/acquisitions of Indian companies** due to the current COVID-19 pandemic.

#### Details:

- The Government has amended **para 3.1.1 of extant FDI policy** as contained in **Consolidated FDI Policy, 2017**.
- It has decided put all FDI proposals from **countries sharing border with India under the government approval route**.
- The so-called **automatic route**, under which the central bank simply had to be informed after money was invested, **has been blocked** in such cases.
- Companies whose beneficial ownership also lies in such countries will have to

undergo **government scrutiny** for any change in foreign holding.

#### Why was the amendment made?

- The changes have been made largely to check the **growing influence of Chinese firms in Indian infrastructure companies and banks**.
- Recently, news surfaced that People's Bank of China increased its stake in Housing Development Finance Corporation to 1.01 per cent from 0.8 per cent.
- While India shares a land border with Pakistan, Bangladesh, Myanmar, Nepal, Bhutan, China and Afghanistan, the move appears directed mostly at China.
- Inflows from Pakistan were under scrutiny anyway, and the other five do not have a past record of buying Indian assets.

#### Present Position:

- A non-resident entity can invest in India, subject to the FDI Policy except in those sectors/activities which are prohibited.
- However, a citizen of Bangladesh or an entity incorporated in Bangladesh can invest only under the Government route.
- Further, a citizen of Pakistan or an entity incorporated in Pakistan can invest, only under the Government route, in sectors/activities other than defence, space, atomic energy and sectors/activities prohibited for foreign investment.

#### Revised Position:

- **1.1(a):** A non-resident entity can invest in India, subject to the FDI Policy except in those sectors/activities which are prohibited.
- However, an entity of a country, which shares land border with India or where the beneficial owner of an investment into India is situated in or is a citizen of any such country, can invest only under the Government route.

- **1.1(b):** In the event of the transfer of ownership of any existing or future FDI in an entity in India, directly or indirectly, resulting in the beneficial ownership falling within the restriction/purview of the para 3.1.1(a), such subsequent change in beneficial ownership will also require Government approval.

### Concerns:

- Businesses in India should ideally be under Indian control. Yet, on a broader level, erecting new hurdles to foreign capital goes against our post-1991 policy approach, the idea of which was to open the economy to money from overseas for the sake of growth.
- In a globalized world, country-wise restrictions can also be gotten around by channelling a disguised investment through a transit country.

### What's in News?

### Details:

- Instructions have been issued to specially focus on helping the downtrodden and needy people in urgent need of food items.
- The employees of Department of Posts (DoP) have **pooled their savings** to distribute food, dry rations and even masks to the needy in

slums, migrant labourers and daily wage earners.

- **Punjab Postal Circle** started "**Food on Wheels**" for construction workers, hawkers, rickshaw pullers, attendants of patients of PGI and migrant labourers stuck in various parts of Chandigarh.

- It aims to raise **awareness about the various intangible cultural heritage elements from different states of India** at national and international level and **ensure their protection**. This initiative is also a part of the **Vision 2024 of the Ministry of Culture**.
- The present items in the list have been collated from the projects sanctioned under the **scheme for 'Safeguarding the Intangible Cultural Heritage and Diverse Cultural Traditions of India'** formulated by the Ministry of Culture in **2013**.
- As of now the list has **more than 100 elements**. It also includes the 13 elements of India that have already been inscribed on the UNESCO Representative List of the Intangible Cultural Heritage of Humanity.
- The list functions as a tentative list for any potential inscriptions on the **UNESCO list of Intangible Cultural Heritage**.

### Classification:

Following UNESCO's 2003 Convention for Safeguarding of Intangible Cultural Heritage, this list has been classified into **five broad domains** in which intangible cultural heritage is manifested:

- Oral traditions and expressions, including language as a vehicle of the intangible cultural heritage;
- Performing arts;
- Social practices, rituals and festive events;
- Knowledge and practices concerning nature and the universe;
- Traditional craftsmanship.

### Power Ministry floats draft Electricity Act

#### What's in News?

- Supply of quality power at affordable prices is essential for sustained growth of the economy of the country.

- For further development of the power sector, Ministry of Power has issued draft proposal for **amendment of Electricity Act, 2003** in the form of **draft Electricity Act (Amendment) Bill, 2020**.
- **Suggestions have been invited from stakeholders within twenty one days.**

**Major amendments proposed in the Electricity Act are as follows:**

#### Viability of Electricity Distribution companies (Discoms)

- **Cost reflective Tariff:** To eliminate the tendency of some Commissions to provide for regulatory assets, it is being provided that the Commissions shall determine tariffs that are reflective of cost so as to enable Discoms to recover their costs.
- **Direct Benefit Transfer:** It is proposed that tariff be determined by Commissions without taking into account the subsidy, which will be given directly by the government to the consumers.

#### Sanctity of Contracts

- **Establishment of Electricity Contract Enforcement Authority:** A Central Enforcement Authority headed by a **retired Judge of the High Court** is proposed to be set-up with powers of the Civil Court to enforce performance of contracts related to purchase or sale or transmission of power between a generating, distribution or transmission companies.
- **Establishment of adequate Payment Security Mechanism for scheduling of electricity:** It is proposed to empower Load Dispatch Centres to oversee the establishment of adequate payment security mechanism before scheduling dispatch of electricity, as per contracts.

- **Strengthening of the Appellate Tribunal (APTEL):** It is proposed to increase the strength of APTEL to **seven apart from the Chairperson so that multiple benches can be set-up** to facilitate quick disposal of cases. It is also proposed to further empower the APTEL to enforce its decisions.
- **Doing away with multiple Selection Committees:** It is proposed to have **one Selection Committee for selection of Chairpersons and Members of the Central and State Commissions** and **uniform qualifications for appointments** of Chairperson and Members of Central and State Electricity Regulatory Commissions.
- **Penalties:** In order to ensure compliance of the provisions of the Electricity Act and orders of the Commission, section 142 and section 146 of the Electricity Act are proposed to be amended to **provide for higher penalties.**

### Renewable and Hydro Energy:

- **National Renewable Energy Policy:** It is proposed to provide for a policy document for the development and promotion of generation of electricity from renewable sources of energy.
- It is also proposed that a minimum percentage of purchase of electricity from hydro sources of energy is to be specified by the Commissions.
- **Penalties:** It is being further proposed to levy penalties for non-fulfilment of obligation to buy electricity from renewable and/or hydro sources of energy.

### Miscellaneous:

- **Cross border trade in Electricity:** Provisions have been added to **facilitate and develop trade in electricity with other countries.**
- **Franchisees and Distribution sub licensees:** Many States Distribution Companies have been assigning the task of distribution of electricity in a particular area or

city to Franchisees / Sub-Distribution Licensees. However, there was a lack of clarity regarding the legal provisions related to this. It is proposed to provide that the Distribution Companies, if they so desire, may engage Franchisees or Sub-Distribution Licensees to distribute electricity on its behalf in a particular area within its area of supply, however, it will be the DISCOM which shall be the licensee, and therefore, ultimately responsible for ensuring quality distribution of electricity in its area of supply.

- This database can also be used to utilise the services of volunteers for enforcing social distancing at banks, ration shops, mandis and for providing help to elderly, physically handicapped and orphanages.
- This will also help States/UTs to move human resources from one location to the other for their utilisation.
- This platform provides anytime onsite delivery of training material/modules through any device (mobile/laptop/desktop).

### **IIA scientists connect Lithium abundance in interstellar space to new Lithium rich red giants**

#### **Context:**

Researchers at the Indian Institute of Astrophysics (IIA), an autonomous institute under the Department of Science & Technology, Govt. of India, have discovered hundreds of Li-rich giant stars indicating that Li is being produced in the stars and accounts for its abundance in the interstellar medium.

#### **Details:**

- The researchers have also associated such Li (lithium) enhancement with central He-burning stars, also known as red clump giants, thereby opening up new vistas in the evolution of the red giant stars.
- Lithium (Li) is one of the three primordial elements, apart from Hydrogen and Helium (He), produced in the big bang nucleosynthesis (BBN) whose models predict primordial Li abundance.
- However, the present measurement of Li in the interstellar medium and very young stars is about 4 times more than the primordial value.
- Thus, identifying sources of Li enrichment in our galaxy has been of great interest to researchers to validate the Big Bang Nucleosynthesis as well as a stellar mixing process.
- Apart from reactions in which high energy cosmic ray particles bombard with heavier nuclei such as carbon and oxygen – producing lighter particles such as Li, stars are also proposed as likely Li source in the galaxy.
- In general, stars are considered as Li sinks. This means that the original Li, with which stars are born, only gets depleted over stars' life-time as Li burns at relatively very low temperatures of about  $2.5 \times 10^6$  K – a range which is easily encountered in stars.
- By employing data from large scale ground and space missions, the research team discovered hundreds of Li-rich giants.
- The researchers determined the evolutionary phase of these giants by analysing the relative positions of thousands of stars using their temperature and luminosity and also subjecting their independent data set to atmospheric oscillations analysis using data from Kepler Space Telescope, a NASA mission for discovering planets.
- By determining their characteristic frequency and period spacing of pressure (p)-modes and gravity (g)-modes, they could differentiate between the stars that have a He-burning core, or inert He ash at the centre due to Hydrogen fusion reaction.
- **Importantly, they showed for the first time that the Li enhancement in giants is associated only with central He-burning stars, which are also known as red clump giants.**
- This is an important discovery that will help to eliminate many proposed theories such as planet engulfment or nucleosynthesis during the red giant evolution in which helium at the centre is not burning.

The purpose of the Bank is to mobilise resources for infrastructure and sustainable development projects in BRICS and other emerging market economies and developing countries to complement the existing efforts of multilateral and regional financial institutions for global growth and development.

NDB has so far approved 14 projects of India for an amount of \$ 4,183 million.

The NDB's President is K. V. Kamath (former chairman of ICICI Bank).

The NDB is headquartered in Shanghai, China.

## Surplus rice available with FCI allowed to be converted to ethanol

### Context:

Surplus rice available with the FCI is allowed to be converted to ethanol for utilization in making alcohol-based hand-sanitizers and for blending in petrol.

### Details:

- The National Policy on Biofuels, 2018 envisages that during an agriculture crop year when there is projected oversupply of food grains as anticipated by the Ministry of Agriculture & Farmers' Welfare, the policy will allow conversion of these surplus quantities of food grains to ethanol, based on the approval of the National Biofuel Coordination Committee (NBCC).
- Accordingly, the NBCC held a meeting in which it approved that the surplus rice available with the Food Corporation of India (FCI) may be converted to ethanol for utilization in making alcohol-based hand-sanitizers and in blending for Ethanol Blended Petrol (EBP) programme.
- The Government of India launched the EBP programme in 2003 for undertaking the blending of ethanol in petrol to address the environmental concerns due to fossil fuel burning, provide remuneration to farmers,

### **A new model to predict ionospheric electron density can help communication/navigation**

#### **Context:**

Researchers from Indian Institute of Geomagnetism (IIG), Navi Mumbai, an autonomous institute of the Department of Science & Technology, Govt. of India, have developed a global model to predict the ionospheric electron density with larger data coverage—a crucial need for communication and navigation.

#### **Details:**

- The research team has developed a new **Artificial Neural Networks based global Ionospheric Model (ANNIM)** using long-term ionospheric observations to predict the ionospheric electron density and the peak parameters.

- **Artificial Neural Networks (ANNs):**

- ANNs replicate the processes in the human brain (or biological neurons) to solve problems such as pattern recognition, classification, clustering, generalization, linear and nonlinear data fitting, and time series prediction, and very few attempts have been made to model the global ionosphere variability using ANNs.

Tracking the variability of the Ionosphere is important for communication and navigation.

The ionospheric variability is greatly influenced by both solar originated processes and the neutral atmosphere origin, and therefore, difficult to model.

Scientists have tried to model the ionosphere using theoretical and empirical techniques; however, the accurate prediction of electron density is still a challenging task.

In recent years, Artificial Neural Networks (ANNs) are showing the potential to handle more complex and non-linear problems.

Keeping these aspects in mind, a novel machine learning approach was implemented by the IIG team in the ionospheric model development using global ionospheric observations.

The researchers developed a neural network-based global ionospheric model by using an extensive database consisting of nearly two decades of global Digisonde (an instrument that measures real-time on-site electron density of the ionosphere by sending the radiofrequency pulses), Global Navigation Satellite System (GNSS) radio occultation and topside sounders observations.

These datasets were processed with various quality control measures to eliminate spurious data points (outliers) and prepared for the training.

Day number, Universal Time, latitude, longitude, F10.7 index (responsible for Photo-ionization), Kp (represents the disturbed space weather conditions), magnetic declination, inclination, dip latitude, zonal and meridional neutral winds were taken as inputs in the study.

The target (output) of ANNs is the electron density as a function of altitude for any given location and time.

The data was trained with the ANNs using a high-performance computer at IIG to develop the ANNIM.

The ANNIM predictions done by the IIG team matched with the incoherent scatter radar and the satellite in situ electron density observations.

Further, the ANNIM successfully reproduced large scale anomalies of the ionosphere.

The ANNIM also captured the general morphological features of the ionosphere during disturbed space weather periods, such as geomagnetic storms which occurs when the magnetic cloud originated from Sun (known as

Coronal Mass Ejection (CME)) interacts with the Earth's magnetosphere.

The model developed by IIG researchers may be utilized as a reference model in the ionospheric predictions and has potential applications in calculating the Global Navigation Satellite System (GNSS) positioning errors.

### **DBT-BIRAC Call on COVID-19 Research Consortium**

#### **Context:**

The Department of Biotechnology and the Biotechnology Industry Research Assistance Council (BIRAC) had invited applications on COVID-19 Research Consortium.

#### **Details:**

- A multifaceted approach is being adopted to ensure that vaccine candidates utilizing different platforms and at different stages of development are fast-tracked through this Research Consortium under funding from National Biopharma Mission.
- Both, repurposing of existing vaccine candidates for immediate protection of high-risk groups, and novel vaccine candidate development was considered while selecting proposals under this call.
- Funding support has been recommended to Cadila Healthcare Ltd for advancing the development of a DNA Vaccine candidate against Novel Coronavirus SARS-CoV-2, and to Bharat Biotech International Ltd for COVID-19 vaccine candidate utilising the inactivated rabies vector platform.
- Furthermore, for the Phase III human clinical trials study of recombinant BCG vaccine (VPM1002) planned in the high-risk population, Serum Institute of India Private Limited (SIPL) will be supported.
- The development of a novel vaccine evaluation platform at the National Institute of Immunology to support SARS-CoV-2 vaccine

development has also been approved for financial support.

- Production of purified immunoglobulin G, IgG, at a commercial scale from COVID-19 convalescent sera and production of high titers of equine hyperimmune globulin for the treatment of COVID infected patients on a large scale will be supported at Virchow Biotech Pvt Ltd.
- Financial support to OncoSeek Bio Pvt Ltd will be provided to create an in vitro Lung Organoid model.
- To boost indigenous production and to scale-up the production of molecular and rapid diagnostic tests, many companies will receive financial support.
- Development and deployment of contactless, affordable thermopile based ultrasonic sensors for the screening of COVID-19 suspects and indigenous production of novel PPE for healthcare professionals will also be supported.

Crone has been provisioned and the rest for medium-term support (1-4 years) will be provided under mission mode approach.

- The key objectives of the package include mounting emergency response to slow and limit COVID-19 in India through the development of diagnostics and COVID-dedicated treatment facilities, centralized procurement of essential medical equipment and drugs required for treatment of infected patients, strengthen and build resilient national and state health systems to support prevention and preparedness for future disease outbreaks, setting up of laboratories and bolster surveillance activities, bio-security preparedness, pandemic research and proactively engage communities and conduct risk communication activities.

- These interventions and initiatives would be implemented under the overall umbrella of the Ministry of Health and Family Welfare.

- All health workers including Community Health Volunteers (ASHAs) have been covered with insurance under the "Pradhan Mantri Garib Kalyan Package: Insurance Scheme for Health Workers fighting COVID-19".

- Personal Protection Equipment (PPE), N95 masks and ventilators, testing kits and drugs for treatment are being procured centrally.

### Epidemic Diseases Act, 1897

#### Context:

Promulgation of an Ordinance to amend the Epidemic Diseases Act, 1897 in the light of the pandemic situation of COVID-19.

#### Background:

- During the current COVID-19 pandemic, there have been instances of the most critical service providers i.e., members of the healthcare services being targeted and attacked by miscreants, thereby obstructing them from doing their duties.

- Members of the medical community, even as they continue to perform relentlessly round the clock and save human lives, have unfortunately become the most vulnerable victims as they have been perceived by some as carriers of the virus.

- This has led to cases of their stigmatization and ostracization and sometimes worse, acts of unwarranted violence and harassment.

- This tends to hamper the medical community from performing their duties to their optimum best and maintaining their morale, which is a critical need in this hour of crisis.

- While healthcare service personnel are duty-bound to serve without discrimination, the cooperation and support from society is a fundamental need for them to perform their duties with confidence.

- Several States have enacted special laws to offer protection to doctors and other medical personnel in the past.

- However, COVID-19 outbreak has posed a unique situation where harassment of the healthcare workforce and others working to contain the spread of the disease has been taking place at all fronts, in various places including even cremation grounds.

- The existing state laws do not have such a wide sweep and ambit. They generally do not cover harassment at home and workplace and are focused more on physical violence only.

- The penal provisions contained in these laws are not stringent enough to deter mischief mongering.

#### Details:

- In this context, the Union Cabinet has approved promulgation of an Ordinance to amend the Epidemic Diseases Act, 1897 to protect healthcare service personnel and property including their living/working premises against violence during epidemics.

- The President has given his assent for the promulgation of the Ordinance.

- **The Ordinance provides for making such acts of violence cognizable and non-bailable offences** and for the compensation for injury to healthcare service personnel or for causing damage or loss to the property in which healthcare service personnel may have a direct interest in relation to the epidemic.

- The current Ordinance is intended to ensure that during any situation akin to the current pandemic, there is zero tolerance to any form of violence against healthcare service personnel and damage to property.

- Violence as defined in the Ordinance will include harassment and physical injury and damage to property.

- Healthcare service personnel include public and clinical healthcare service providers such as doctors, nurses, paramedical workers and community health workers; any other persons empowered under the Act to take measures to prevent the outbreak of the disease or spread thereof; and any persons declared as such by the State Government, by notification in the Official Gazette.

### • **Penalty under the Ordinance:**

- Commission or abetment of such acts of violence shall be punished with imprisonment for a term of three months to five years, and with fine of Rs.50,000/- to Rs.2,00,000/-.

- In case of causing grievous hurt, imprisonment shall be for a term six months to seven years and with fine of Rs.1,00,000/- to Rs.5,00,000/-.

- In addition, the offender shall also be liable to pay compensation to the victim and twice the fair market value for damage of property.

Offences shall be investigated by an officer of the rank of Inspector within a period of 30 days, and trial has to be completed in one year, unless extended by the court for reasons to be recorded in writing.

## New Varieties of Anthurium

### Context:

A woman innovator from Thiruvananthapuram, Kerala, has developed ten varieties of Anthurium, a flower with high market value, by cross-pollination.

### Details:

- Anthurium is a vast group of beautiful blooming plants available in a wide range of colours.
- The plants of the varieties have a high demand due to its use as indoor decorative plants.
- During the last year, over 8500 plants as well as flowers, have been sold in the market mainly in Pune and Thiruvananthapuram.
- The innovator has been propagating it through cuttings & seeds and supplying some plants and flowers throughout the country, but she was unable to meet the demand due to the time-consuming technique of propagation method.
- Therefore, the National Innovation Foundation – India (an autonomous body under the Department of Science and Technology) has facilitated mass multiplication and large scale production of four highly demanded varieties through tissue culture technique at the Indian Institute of Horticultural Research (IIHR), Bangalore, for the diffusion of the varieties in similar agroclimatic zones of the country.
- **Salient features of the new varieties of anthurium are:**
  - Large beautiful flowers
  - Different colours of spathe and spadix
  - Long stalks
  - Better shelf life

- Good market value

### Anthurium:

- Anthurium is one of the best domestic flowering plants in the world.
- They are beautiful but also purify the surrounding air and remove harmful airborne chemicals like formaldehyde, ammonia, toluene, xylene, and allergens.
- Because of its importance in removing toxic substances from the air, NASA has placed it in the list of air purifier plants.
- Anthurium has larger economic importance because of its eye-catching and beautiful inflorescence and fetches a good market price.

### Indian Institute of Food Processing Technology (IIFPT)

#### Context:

IIFPT supports the battle against COVID-19 by manufacturing and supplying nutrient-rich foods to COVID-19 patients.

#### About IIFPT:

- The IIFPT is a pioneer research and educational institution under the Ministry of Food Processing Industries, Government of India.
- It was started by eminent scientist Dr. V. Subrahmanyam as an R&D lab in the Modern Rice Mill complex of the Thanjavur Co-operative Marketing Federation (TCMF) at Tiruvarur, Tamil Nadu.
- The mandate of the Institute at its inception was to seek solutions for preserving high moisture paddy because the paddy harvest season in Southern India coincided with the tail end of the South West monsoons.
- The Institute was later upgraded as a national laboratory with the name Paddy Processing Research Centre (PPRC) in 1972.
- At the time of up-gradation the mandates of the Institute were also changed and the scientists in the Institute focused their research in identifying technologies for post-harvest procession and preservation of paddy.

- The Institute was moved to its current location at Thanjavur in 1984.
- Considering the vital importance of strengthening R&D efforts in the post-harvest processing, preservation and value addition of raw agricultural produce, the Ministry of Food Processing Industries strengthened and upgraded the PPRC as a National Institute in February 2008 and renamed it as Indian Institute of Crop Processing Technology (IICPT).
- In 2017, it was again renamed to its current name, IIFPT.
- It currently focuses on providing solutions to all food processing areas including fish, meat and dairy products processing through intensive research and development activities.
- It is engaged in the R&D of food grain processing, value addition, by-product utilization through bio-processing, process and product development.
- IIFPT offers B.Tech., M.Tech. and Ph.D. programs in Food Process Engineering and M.Tech. programs in Food Science and Technology and Ph.D. in Biotechnology.

- INST is an autonomous institute under the Department of Science and Technology.

### Details:

- The scientists have tested **carbon nitride quantum dots (g-CNQDs)** for **visible-light-driven antibacterial activity** and found it to be efficient.
- These nanomaterials possess **enhanced biocidal activity** attributed to larger surface area of g-CNQDs having more reactive sites and optical absorption both in the ultraviolet and visible regions.
- The g-CNQDs have the ability to **generate Reactive Oxygen Species (ROS)**. The ROS rapidly interact and damage the immediately available biological macromolecules such as lipids present on the cell membrane or envelope and proteins present on the cellular surface, towards inactivation of the microorganism.
- The **mechanism of inactivation is non-specific to a particular pathogen, as lipid and protein are major components of the inhabitants of the microbial world.**
- The scientists are exploring ways of incorporating doped and undoped carbon nitride-based materials into cloth fabrics that can continuously produce reactive oxygen species (ROS) under optimal humidity and temperature for the antimicrobial activity.
- It was explained that aerosol droplets generated during sneezing have enough moisture that might help in ROS mediated disinfection of any infectious agents in the droplet, once it comes into contact with the nanomaterial sewn fabric under sunlight or ambient white light exposure.
- The **dependence on visible light is also advantageous over regular ultraviolet mediated disinfection**, which requires cautious handling of the UV light-emitting devices.

### Advantages:

- The team has suggested it to be a viable anti-bacterial alternative to metal/non-metal semiconductors and expensive silver, thus making it cost-effective.

- It is also **biocompatible with mammalian cells.**

- This scheme will help in streamlining planning and revenue collection in rural areas and ensuring clarity on property rights.
- The scheme will also enable the creation of better-quality Gram Panchayat Development Plans engaging Drone Surveying technology.
- The aim of this scheme is to provide people in the rural areas with the right to document their residential properties so that they can use their property for economic purposes.

## Petersberg Climate Dialogue

### Context:

India, along with 30 countries, deliberates on issues of Climate Change in the first ever virtual Petersberg Climate Dialogue.

### About the Petersberg Climate Dialogue:

- The first virtual Climate Dialogue, was the eleventh session of the Petersberg Climate Dialogue.

- This has been hosted by Germany since 2010 to provide a forum for informal high-level political discussions, focusing both on international climate negotiations and the advancement of climate action.

- The virtual XI Petersberg Climate Dialogue was co-chaired by Germany and the United Kingdom, the incoming Presidency of the 26<sup>th</sup> Conference of Parties (COP 26) to United Nations Framework Convention on Climate Change (UNFCCC).

- The dialogue saw participation from ministers and representatives of about 30 countries.

- The Climate Dialogue was originally an initiative of German Chancellor Angela Merkel.

- It is hosted by the German Federal Ministry for the Environment, Nature Conservation, Building and Nuclear Safety.

## ADB's COVID-19 Active Response and Expenditure Support Programme (CARES Programme)

### Context:

India signed \$1.5 billion loan with the ADB to support India's COVID-19 immediate response.

### Details:

- This move focuses on immediate priorities such as disease containment and prevention, as well as social protection for the poor and economically vulnerable sections of the society, especially women and disadvantaged groups.
- The loan was granted under the Asian Development Bank's COVID-19 Active Response and Expenditure Support Programme (CARES Programme).
- Earlier, the ADB's Board of Directors approved the loan to provide budget support to the government to counter and mitigate the adverse health and socio-economic impact of the pandemic.
